

# Terms and Conditions – Christmas BBQ Promotion 2019

NSW Permit Number: LTPS/19/38757

## 1) The promotion

The promotion is the Christmas BBQ Promotion 2019 (**Promotion**).

## 2) The Promoter

The promoter of the Promotion is Vantage Fuels Pty Ltd ACN 151 023 040 of 7 Woodlands Court, Bendigo East, Victoria, phone: (03) 5441 0600 (**Promoter**).

## 3) Promotion Period

The Promotion will commence on 4 November 2019 and will conclude at 12.00pm 19 December 2019 (**Promotion Period**).

## 4) How it works

During the Promotion Period, a customer who makes an Eligible Purchase and who satisfies the Entry Criteria is eligible to:

- win an Instant Win Prize (see paragraph 7); and
- go in the draw to win the Major Prize (see paragraph 8).

## 5) Eligibility criteria

To enter the Promotion, a person must:

- be over the age of 18 (unless parental consent is obtained by the participant. Written confirmation of parental consent may be required if the Major Prize is won by any person who is under the age of 18);
- be a customer of the Promoter's business; and
- not be an employee of the Promoter (**Eligibility Criteria**).

Proof of purchase may be required if a Prize is won by any person who is related, in any way, to any employee of the Promoter.

## 6) Eligible purchase

To enter the Promotion, a customer must purchase any of the following products from any of the Promoter's Participating Stores (**Eligible Purchase**):

Once an Eligible Purchase has been made, the customer must obtain an entry token (containing a unique entry code) (**Entry Token**) from the staff member who processed the Eligible Purchase.

## 7) Instant Win Prize

To reveal if the customer has won an Instant Win Prize, the customer must scratch the scratch panel on the Entry Token. If the scratch panel reveals that an Instant Win Prize has been won, the customer must provide this part of the Entry Token to the staff member to redeem their Instant Win Prize.

## 8) Major Prize

To go in the draw to win the Major Prize, the customer must:

- retain the portion of the Entry Token containing their unique entry code;
- go to **[www.bowserbeancomp.com.au](http://www.bowserbeancomp.com.au)**; and

### 9) Winner consents
